**REPRESENTATIVE ACCOMPLISHMENTS**

*Legislative:* Lead sponsor of more than two dozen county laws that promote clean energy, including the 1<sup>st</sup> in the nation county green bank and energy benchmarking law, residential and commercial PACE programs, and a requirement that the county buy 100% renewable energy. Led the County in adopting a Bus Rapid Transit master plan and, at the regional level, played a key role in securing dedicated funding for the Washington region's Metro system. At the state and federal levels, principal drafter of the Maryland Electric Service Quality Reliability Act, a law that required Maryland electric utilities to meet electric reliability standards; drafter of Sec. 1270 of the Energy Policy Act and its legislative history, a provision that prevented Enron from collecting hundreds of millions of dollars in "termination" payments from defrauded customers.

*Legal:* Lead counsel for the Coalition for Performance Based Ratemaking before the Maryland Public Service Commission successfully advocating for performance based rates; lead counsel for Nevada utilities on successful briefs to the 9<sup>th</sup> Circuit Court of Appeals challenging FERC's failure to reform contracts subject to Enron's market manipulation in *Public Utility District No. 1 of Snohomish County v. FERC*; briefed United States Supreme Court in *Morgan Stanley Capital Group Inc. v. Public utility District No. 1 of Snohomish*.
